The Summary of Memorandum & Articles of the Association (For Reference only)

Aims & objectives:

To consider and investigate all questions connected with the welfare and benefit of the members of the association, to promote friendships between them and to contribute to all charitable and social welfare funds and institutions.

Principle Activities:

- (1) To consider investigate & enquire all questions connected with the welfare and benefit of the members of the association as well as those participating in the segment;
- (2) To conduct various recreational activities;
- (3) To conduct seminar, forum and research project in enhancing up-to-date shoe technical knowhow and business-related knowledges to our members in aim of advancing them to adapt the changing business environment, and helping them in business promotion and development as well as the problem-solving with day-to-day business operation;
- (4) To consider, investigate and enquire into all questions connected with trade, commerce, industry, shipping and transportation or representative of any proprietor partner in dealing in the business of importing, exporting, trading manufacturing, wholesaling, retailing, shipping and transporting of leather boots, shoes, other leather articles and shoe materials in Hong Kong is qualified to be a member of the association.

Membership Qualification:

Every person or firm, "Hong" corporation or limited company being a merchant or merchants or a proprietor or partner or manager or representative of any proprietor partner in dealing in the business of importing, exporting, trading, manufacturing, wholesaling, retailing, shipping and transporting of leather boots, shoes, other leather articles and shoe materials in Hong Kong is qualifies to be a member of the association.

Any candidate for membership shall sign and deliver application to the secretary and counter-signed by one member as proposer. Such application shall be considered and approved by the standing committee. The Approved application will be deemed valid after payment of the relevant scale of membership fee by the candidate.
